

# **CEO COMMUNIQUE**

#### 7 May 2020

## 2020 Major Investment Round 3

The Board of the Soil CRC met last week and considered the recommendations of the Research and Adoption Committee (RAC) regarding project proposals submitted to the Soil CRC under the 2020 Major Investment Round 3 (Round 20-1).

In summary, the Board approved 8 projects with a project lifetime commitment of \$3.5m.

The Research and Adoption Committee assessed all 11 project submissions against the criteria outlined in the Guidelines for Proposals and subsequently ranked and prioritised them. The recommendations of the RAC were presented to the Board, who after considerable discussion, approved the recommended projects with some further minor modifications. Some projects will require budget and/or delivery modification before being contracted and we will be working with Project Leaders and their partners in coming weeks to achieve this.

The projects that have been approved by the Board under Round 20-1 are as follows (Project title, Project Leader, lead organisation):

# Program 1 – Investing in high performance soils

- Activating financial markets to reward soil stewardship Nicholas Pawsey, Charles Sturt University
- On-farm drivers of decision making across Australian farming systems Hanabeth Luke,
   Southern Cross University
- Addressing barriers to adoption: Building farmer innovation capability Phase 2 David Falepau, Charles Sturt University

## Program 3 – New products to increase fertility and function

- A further project was provisionally approved subject to modification and subsequent approval by the RAC.

In addition, at its previous meeting, the Board also approved an out-of-session project in Program 4, with significant GRDC co-investment:

 More profitable crops on highly calcareous soils by improving early vigour and overcoming soil constraints – Nigel Wilhelm, Primary Industries and Regions South Australia (PIRSA).

All Project Leaders (both successful and unsuccessful) and their organisations have been informed directly of the Board decisions and are now in the process of communicating to their project teams. Whilst the Project Leaders and their organisations are listed above, all projects involve collaboration across a number of CRC participants, including many farmer and grower group participants.

Further details on each of these projects will be placed on the Soil CRC website in coming weeks, including information on the value and benefit that each project will deliver to farmers, in the short or long term.

I would like to thank and acknowledge everyone who contributed to this process, especially the Project Leaders who coordinated the scientific thinking, the writing and the budget preparation with each of their proposed project teams.

This brings the total amount of cash funds that the Soil CRC has now committed to projects to over \$19 million. It is worth noting that another four PhD students will be funded through projects in this round, bringing the total so far to 38. We will make a similar call for projects later this year and a further call for PhD students in 2021.



## **COVID-19 impacts**

The known and potential impacts of COVID-19 on the Soil CRC were discussed at the recent Board meeting. The Board endorsed a policy of continuing to maintain timely payments to projects, even if milestones are delayed due to COVID impacts. They recognised that in principle, projects may require additional funds for completion if they are delayed due to COVID, subject to approval of variations. In doing so, the Board stressed the importance of all of our partners continuing to employ the specialist human capability required to deliver the activities of the Soil CRC, now and into the future.

Project team members are requested to update Project Leaders on impacts of COVID on project delivery, and in turn, Project Leaders should be keeping Program Leaders informed of any disruptions. As notified in my last Communique, when we have a clear picture of the total extent of disruption caused by COVID-19 restrictions on project milestones and deliverables, we can instigate formal variations to account for the agreed revisions to a project.

Above all, it is important that you follow the advice and guidelines of the relevant authorities, as well as those of your employer organisation, to protect your own health and safety and limit the spread of COVID-19 as much as possible.

## **Program Milestone Review**

While the Soil CRC has made good progress against all of its milestones to date, this review provides the opportunity to ensure that the contracted milestones are the most appropriate going forward.
